Task: For Australia or a country of your choice:

- 1) Identify, for each of 2-3 WHO health system building blocks, one area (hence 2-3 areas in total) that you believe need strengthening or addressing. Explain why you believe there is a need to address these particular areas.
- 2) For **one** of these only, recommend how the issue might be addressed/strengthened (500-800 words).

ADDITIONAL REQUIREMENTS

Word count: 2000 words (allow +/- 10%). Marks will be lost if your assignment is less than or exceeds the total word limit. The word limit does not include the list of references. You can use up to 1 figure and 1 table of data. These will not be included in the word count.

Guidance in structure and concentration of effort:

****Please provide an introductory paragraph.** In the introduction briefly state the purpose of your written piece (e.g. questions to be answered) (no more than 150 words).

****Provide a conclusion at the end of your written piece that neatly sums up your main points** (no more than 150 words).

A quality aspect of your main piece will be the use of the current research/policy literature to support your main points. Justify with evidence where relevant.

Quality assessment criteria

As well as meeting the above task specific requirements, your report should demonstrate (and will also be assessed against):

- Clarity, conciseness and logic in the expression of ideas and concepts presented
- Demonstrated comprehension of the subject material
- Application of key concepts presented in class, in the readings or elsewhere – where relevant.
- Research skills in sourcing relevant information/sources
- Evaluation and synthesis of evidence/information derived from other sources
- Quality in presentation
- Analytical in nature – not just descriptive (e.g., explaining why rather than just describing)
- Originality/appropriate use of citations and referencing

Recommended (but not compulsory) APA style.
