# Revisit: Duncan-Andrade's Equity

Thus, an equal education attempts to provide the same education to everyone, which is not equitable. An equitable education suggests resource allocation based on context, which would include attention to funding and teachers but in a manner that pays closer attention to the specific needs of a community. An equitable education is better defined as a culturally relevant education (Ladson-Billings, 1994) in that it is designed to address the material conditions of students' lives while maintaining a high level of intellectual rigor. At the same time, an equitable education encourages students to embrace the sociocultural richness of the community as a resource, rather than as a barrier to be overcome.




## How did we get here?






